## **WEDDING DAY LOGISTICS:**

ON THE WEDDING DAY, THE HAIR WILL BE DONE FOLLOWING A SCHEDULE. THE BRIDE MUST COMMUNICATE THE IMPORTANCE OF BEING ON TIME AND PROPERLY PREPARED. EVERY PERSON GETTING THEIR HAIR DONE IN AN UPDO, HALF-UP STYLE OR CURLS MUST HAVE THEIR HAIR ALREADY BLOWN DRY. THE STYLIST WILL NOT ALLOW TIME FOR THIS. IF SUCH A CASE ARISES, THE STYLIST WILL CHARGE EXTRA TO BLOW DRY (IF TIME PERMITS) OR THE SERVICE WILL BE FORFEITED AND THE CHARGE WILL STILL APPLY. THE BRIDE MUST CONFIRM AND COMMIT TO THE NUMBER OF SERVICES STATED ABOVE. CHARGES WILL INCLUDE ALL PEOPLE STATED ABOVE. THE STYLIST NEEDS A DESIGNATED SPACE TO SET UP WHEN ON LOCATION. THE BRIDE IS RESPONSIBLE FOR CLEARING AN AREA BEFORE THE STYLIST ARRIVES. THE STYLIST WILL NEED A WORK AREA WITH A CHAIR NEAR AN OUTLET IN A NO WALK-THROUGH TRAFFIC AREA. GOOD LIGHT AND A MIRROR IS A PLUS! IF SERVICES CANNOT BE PERFORMED DUE TO INSUFFICIENT WORK CONDITIONS OR TARDINESS, ALL FEES STILL APPLY. THE HAIR STYLIST WILL NOT BE HELD LIABLE FOR ANY INJURIES THAT SHOULD ARISE WHILE ON LOCATION.

## **FEE DETAILS:**

THERE IS A \$500 MINIMUM FOR ALL ONSITE SERVICES

DEPOSIT:

**A DEPOSIT OF HALF IS DUE AT LEAST 30 DAYS IN ADVANCE TO HOLD THE DAY. THIS IS NON-REFUNDABLE. YOUR SPOT IS NOT GUARANTEED UNTIL YOUR DEPOSIT AND SIGNED CONTRACT IS RECEIVED.**

## **TRIAL RUN:**

A TRIAL RUN IS RECOMMENDED FOR THE BRIDE. BASED ON AVAILABILITY, THE ACTUAL APPOINTMENT CAN BE UP TO 1 WEEK BEFORE THE WEDDING. THE TRIAL WILL TAKE PLACE IN THE SALON.

## **WEDDING DAY:**

IT IS VERY IMPORTANT THAT WE START ALL SERVICES ON TIME TO ENSURE WE STAY ON A SCHEDULE. IF START TIME IS EARLIER THAN 8AM, THERE WILL BE AN ADDITIONAL FEE OF \$100 PER HOUR.

BRIDAL HAIR: \$195 (includes one practice)

BRIDAL MAKE UP: \$150 (includes one practice)

BRIDESMAIDS HAIR \$75

BRIDESMAIDS/MOTHER OF THE BRIDE/GROOM MAKE UP: \$75

EYELASHES (application w/make up): \$10

LASHES ONLY: \$15

MOTHER OF THE BRIDE/GROOM: \$45 FOR BLOW DRY AND STYLE. \$75 FOR UPDO

CLIP IN EXTENSION APPLICATION: \$20

**TRAVEL:**

THERE IS A \$75 TRAVEL FEE PER STYLIST FOR LOCAL VENUES. TRAVEL FEES WILL BE NEGOTIATED IF THE DISTANCE IS GREATER THAN 15 MILES. THE BRIDE WILL BE RESPONSIBLE FOR PARKING FEES THE STYLIST MUST PAY AT THE WEDDING LOCATION.

**THIS CONTRACT IS DUE 30 DAYS PRIOR TO THE WEDDING DATE OR THE DATE WILL BE RELEASED AND MADE AVAILABLE ON A FIRST COME, FIRST SERVED BASIS.**

ONCE THE CONTRACT IS SIGNED AND THE DEPOSIT IS MADE, YOU ARE RESPONSIBLE FOR THE REMAINING AMOUNT DUE ONE WEEK BEFORE THE WEDDING DAY. IF ANY PERSON FROM THE WEDDING PARTY DECIDES NOT TO GET THEIR HAIR DONE THE DAY OF, THEY WILL NEED TO NOTIFY ME NO LATER THAN 2 WEEKS BEFORE THE WEDDING DAY OR THEIR DEPOSIT WILL NOT BE REFUNDED.
